Permission for Display of Student Artwork¹

Pursuant to Kent State University policy, students own the copyright to the artwork they create as part of their coursework.² Kent State University is seeking your permission to publicly display digital reproductions of your artwork on a publicly accessible Website. If you agree to permit the University to display your artwork as set forth in this agreement, please complete the following permission form:

1. Ownership of the Artwork: I _____ am the creator and owner of the copyright to the artwork described below:

(a) Subject to 1(b) below, I represent that the Artwork is solely of my creation and that no other individual or parties hold any copyright interest in any portion of the work, and that use of the Artwork is not subject to any grant or restriction that would prevent its use consistent with this permission.

(b) If the Artwork incorporates another individual's or parties' copyrighted work, I represent that I have obtained permission from the copyright holder to create a derivative of, and reproduce the work as set forth in this permission.

2. Grant of Permission: I hereby give nonexclusive permission for the University to display a digital reproduction of the Artwork on the KSU Library-administered Website <http://digitalcommons.kent.edu> or future migrations thereof (the "Website").

3. Duration of Permission: The permission granted herein shall last in perpetuity, beginning on the date set forth below. Notwithstanding the preceding, I may terminate this permission upon fourteen (14) days written notice to the Library Dean's Office of my desire to have my Artwork removed from public display.

4. Attribution: As creator of the Artwork, I hereby authorize and consent to the display of my name and likeness on the Website in connection with the display of the Artwork.

¹ "Artwork" as used herein shall mean illustrations, drawings, paintings, photographs, or other non-textual artistic works.

² 3342-5-10 University policy regarding copyrights.

(A) Policy statement.
